Annual Report

11th Annual General Meeting for the FY 2020-2021 OF THE TRUST held held on 12.05.2021

Dear Trustees:

I welcome you to the 11th Annual General Meeting of the TRUST like every year. I also place before you the report of the performance of the Organisation during the year 2020-2021 to apprise you of the functioning of TRUST.

To bring full clarification OF OUR PERFORMANCE during the last Financial year, I SUBMIT THE ANNUAL REPORT ALONGWITH WITH THE STATEMENT OF ACCOUNT in order to bring all the details before you for your information.

It was informed to you in our last AGMs that we had concentrated our activities mainly on eye related Camps with special stress in Organising such camps in the remote areas at villages of Districts.

To organize such FREE CAMPS with distribution of Free spectacles and Free Cataract Surgery of the Identified Patients are expensive and totally depends on donation from Individuals/Society/Trust . Corporate Sector/Company will only provide us Fund/Donation for Capital Goods and or to create assets which will give utility to the beneficiaries .

We approached before the Kolkata Gujrat Club and M.P.Birla Eye Clinic to extend their support to us for Eye cataract Surgeries and Distribution of Spectacles at FREE of Cost or to sponsor the CAMPS . They had given their consent and granted our prayer to organize Camps at the places where we there are needed.

We organized two Camps one at Karkai Ramkrishna Vivekakanda Sangha, Pingla, Midnapur where 210 Patients attended the Camp out of which 45 were detected and advised for Cataract Surgery with IOL Implantation and 152 Patients were advised for Spectacles. BUT OUT OF 45 PATIENTS OF SURGERY, ONLY 22 PAITIENTS WERE TURNED UP. All the Surgeries were done at FREE of Cost and also Spectacles were also given at Free of cost. 3 PATIENTS HAD CARDIAC PROBLEM BUT SURGERIES WERE DONE UNDER SUPERVISION OF ONE CARDIOLOGIT. THE FEES OF THE CARDIOLOGISTS WERE BORNE BY US SEPARATELY. THE SURGERIES WERE TOTALLY SUCCESSFUL AND THE PATIENTS WERE VERY HAPPY.

MOREOVER, THREE PATIENTS WERE IN CRITICAL PLIGHT AND THEY WERE CALLED IN AT THE M.P. BIRLA EYE HOSPITAL, KOLKATA. THEY WERE THERE EXAMINED THROUGH AND THROUGH AND ADVISED FOR SPECIAL TYPE OF COSTLY SPECTACLES WHICH WERE PURCHASED BY US AND GIVEN TO THEM. THE CHILDREN WERE VERY HAPPY HAVING GOT BACK THEIR FULL VISION as they were students and could not read specially at night time. Now they can read everything in day and night time also.

About HEALTH CENTRE

<u>We</u> apprised you in our last AGM report that a talk was going on with an NGO who are interested to work jointly with us. Negotiation was fruitful and positive and after some sitting with them and considering the pros and cons we may proceed jointly to set up a Primary level health Centre with in bed facilty. We have already started to function jointly at the Hospital Premises and there one room has been allotted to us

Relief Work:

As you all are in the know that due to COVID 2019 there was declared a LOCK DOWN and contentment was declared in some ZONEs . People could not go out of their home in fear of pandemic and naturally their livelihood in a very challenged state of affair . We were requested from various corner for arranging relief of FOOD items for them. We therefore jointly with Belgharia Vivekananda Sevasadan Organised Door to door Distribution of Food items to the people who are in distress and needy. Since paucity of FUND we could not continue the same for a long time . But extended to some satisfactory extent

CONCLUSION:

In our last AGM we conveyed that as per Deed of TRUST, our SOCIETY MAKING IMPELLENT LIVING EFFORTS (SMILE) Account to be dissolved and the entire Assets and Liabilities to be transferred to our TRUST Account in the name and style "SMILE"-a Registered Public Charitable Trust.

Since the BELGHARIA VIVEKAKANDA SEVASADAN established in the year 2010 through the instrument of Deed of Trust being a Joint Project of BELGHARIA PRAYAS SANTHYA and SMILE with a view to set up a full fledged EYE Hospital with 45 BEDS.

Till to day Society Making Impellent Living Efforts have spent more than Rs. 36.00 lakhs for construction and Equipments/devices for BELGHARIA VIVEKAKANDA SEVASADAN.

In compliance of the TRUST DEED of SMILE, we were trying our best for 12A & 80 G registration but due to some lapses it could not be materialized.

WE ALSO CONVEYED THAT we had given assignment for 12 A Registration and 80 G under IT Act and it is learned that the same is in very advance progress and we shall at any time get the approval from IT Department.

We also given the task of CSR Registration with MCA and it will take place as soon as we shall receive the grant of 12A & 80 G Registration with Income Tax Department

I further request all of you to please try your level best to tap your every source at every corner for having more donation as you are all in the know that how we are passing through the plight of our economical constraint and as the Society's Account is going to be dissolved , we have to take additional efforts for continuing our activities through the TRUST's Account.
